## Prepare Your Estate Plan and Will

Assets and Personal Property
List your assets. Make a separate list of the
personal possessions you want to distribute.

### People

Think about the people in your life and their needs. Decide who you want to receive your assets and your personal possessions.

#### Professional Advisors

Determine the professional assistance you will need – estate attorney, tax accountant, trust personnel.

#### **Modest Estate**

A Will is a very important document for a modest estate. Your instruction about the distribution of your estate eliminates the burden on others to guess your wishes. And, you loved ones will treasure the possessions you hold dear, a loving gift to them.

Seek recommendations from friends, the trust department of your bank, or the bar association.

Choose an attorney who specializes in estate planning.

Request an estimate of charges before you set the appointment with an attorney, or other advisor.

Retain counsel who meets your specific needs; one you are comfortable with. A qualified attorney will advise you about:

- Tax deductions
- Compliance with state laws
- Distributing your assets only as you wish

#### A Current Will or Trust

Review your document at least every five years. Have an attorney evaluate your document when you move to another sate, experience a major life change, retire, your children reach adulthood, or if you have grandchildren.

You can add a bequest for SAM to your existing arrangement through a simple codicil which your attorney writes.

Once you have taken care of your family, loved ones and friends consider the powerful works of charity you can ensure through your Will.
